JCCI functions on three principles i.e., scientific excellence, publication ethics and transparency. It makes mediatory that every article is submitted only through the online manuscript submission system managed by Longdom as the publisher.

Journal of Clinical and Cellular Immunology is the most preferred and highly accessed a peer-reviewed open access Journal in the field Immunology. At many instances editorial board members also prefer to submit their articles. Such practice is common in other reputed specialty Journals. In fact, JCCI encourages editorial board members to actively contribute. However, no special privileges are given to anyone. All the submitted manuscripts including editorials are subjected to strict peer review process. JCCI follows a double-blind peer review process where identity of reviewers and authors is not revealed to each other. The review generally involves three to six subject experts.

The editorial team consisting of associate editors and assistant editors are involved in the entire article cycle starting from submission to final acceptance. To minimize possibility of bias the entire review process is structured carefully. JCCI is supported by an outstanding Editorial Board of more than international researchers.

Over 100 articles were submitted in which 34 qualitative articles which include original research, review articles, case reports, short communications, image articles etc. On an average 4-5 articles are released for an issue according to the frequency of articles. In an average the article acceptance or rejection will be informed to author within 21 to 30 days of initial submission whereas the preliminary quality check result will be acknowledged within 24 to 48 hours of initial submission.

Authors can submit manuscripts and track their progress Editorial Manager System is an online submission and review system. Authors can easily track their manuscript status through the Editorial tracking system easily. Reviewers can download manuscripts and submit their opinions. Editors can manage the whole submission /review /revise /publish process. Publishers can see what manuscripts are in the pipeline awaiting publication. E-mail is sent automatically to concerned persons when significant events occur.

In 2019, JCCI has opted to use social networking platforms such as Twitter, Linked In, and Facebook to interact with authors, reviewers and editors along with the public and renowned professionals. Journal is having more than 300 followers in twitter where the recent issues regarding Immunology Research are posted on daily basis. For easy contact of authors JCCI has provided with whatsapp so that for any queries or concerns authors can easily contact editorial assistant. Along with these we are having the LinkedIn account.

In 2019, JCCI has completed a decade in publication history with the support of authors and their research works. In these 10 years, the articles were published with rapid peer-review process and we are expecting to do so in future.

Moreover, we would like to thank our readers for their support. We are having more than 3500 readers globally and this will be only possible with open access journals. Our journal provides its google analytics report and the visitor's traffic is the benchmark for the success of any scientific journal and the Journal of Clinical and Cellular Immunology is constantly attracting viewers across the world. Readers from the major countries including China, United States, Japan, United Kingdom, India, Italy and Nigeria visit our journal domain to learn about the ongoing research activities in this field.

For its upcoming volume of JCCI, we will be providing the same features just like 2019 and with the authors support and reviewers work we will go further with 6 issues per year and with more assistance from Editorial team we will try coin special issue related to the topic of our journal.
