The journal accepts manuscripts in Clinical Pharmaceutical Practice, Pharmaceutical Care Regulations, Pharmaceutical Care in hospital and community pharmacy, pharmacotherapy, pharmacoepidemiology, Pharmacogenomics, Pharmacokinetics, Pharmacoeconomics, clinical pharmacokinetics, genomics experimental research, health education, and hospital pharmacy administration, drug utilization evaluation review, medication safety, Drug and Poison Information Services and health services research are welcome.

During the calendar year of 2019, JPCHS received a total of 23 manuscripts, out of which 10 articles (45%) were rejected in the preliminary screening due to plagiarism or being out of the format and peer review process. In the 3 issues of Volume 6 published during the year 2019, a total of 13 articles were published. Articles were published from authors all around the world. Globally articles have been accessed by the research scientists and also cited.
