During the calendar year of 2019, JCNM received a total of 30 manuscript, out of which 25 articles (70%) were rejected in the preliminary screening due to plagiarism or being out of the format and peer review process. During 2019 around 10 articles were subjected for publication after they are accepted in the peer review process.
