In such case with positive attitude developing towards all diverse identity that the person or the community building familiarity with as if stating all belongs to me personally at private level or all belongs to us as the communal level without edifice distinction. In such way, without partiality, preconception, discrimination, prejudice, stereotype and jaundiced eye taking hold towards any that the entity consideration given know well and accustomed with usually language matters of identity of such as the case of multilingualism possibly must be likely consideration given while the one that with fluency or partially acquiring skill of communication in the area of linguistic study as if commonly stating all belongs to us as the case make us to communicate each other or with others possibly without alien mentioning in relation to the lack and absence of communication as the case issue of course related to the linguistically consideration giving of all that the consideration giving familiar with as if stating all belongs and I know you know and stating all totally belongs to us as the case all as if among the consideration giving of the same totally all makes one and unity with in diversity as all also the identity belongs to us in common. NORMATIVE THEORY OF IDENTITY
