The physics analyses up to 2001 are already completed [1] and they reveal even larger effects than those previously reported, with OA/non-OA citation ratios of 2.5- 5.8 [2]. OA dramatically increases the number of potential users of any given article by adding those users who would otherwise have been unable to access it. The main reason why a user may not have access to an article may be that their institution could not afford the access-tolls of the journal in which it appeared and/or the institution decides to grant the access to more trendy journals but the researcher finds one or more articles of the journal important for research. Therefore, OA improves both readership and citation impact.

The journals published in OMICS are added to Directory of Open Access Journals (DOAJ) which provides many benefits including:

The journals with PDF content are included in long term preservation project. This project is lunched from April 2009. Publishers having their journals listed in DOAJ will get the opportunity to have all their full text research articles permanently archived and secured for the future.

DOAJ is Open Archives Initiative (OAI) compliant. The OAI develops and promotes interoperability standards that aim to facilitate the efficient dissemination of content.

The DOAJ provides a platform for open access journals to gain greater visibility and thereby increase their readership, statics shows more than 435000 daily successful global downloads from DOAJ site.
