

## Forensic 2020: Meeting the Pedophile: Attitudes toward Pedophilia among Psychology Students-Rebecca Heron- University of Houston-Victoria

### Abstract

Adverse consequences of stigma towards pedophilia can, among other things, increase dynamic risk factors for sexual offending. Decreasing stigma, therefore, is a plausible approach in the attempt to prevent child sexual abuse. Stigma research suggests that providing direct contact to a stigmatized individual is the most efficient way of reducing stigma. The present study involved an educational intervention, followed by direct contact to a pedophile, to maximize effectiveness. It aimed at finding out whether a dichotomous anti-stigma intervention can change psychology students' attitudes towards pedophiles regarding perceived dangerousness, intentionality, deviance, and punitive attitudes. In a one sample pre-post design, 162 students of the University of Groningen attended a lecture about pedophilia, which was held by a psychology master's student. Participants learned about child sex offending and pedophilia in addition to the importance of distinguishing between pedophiles and child sex offenders (CSOs). The guest lecturer Gabriel shared his experiences about growing up, coping, and living with pedophilia. Results of the Wilcoxon signed-rank test revealed significantly diminished negative attitudes towards pedophiles after the intervention. Students perceived pedophiles as less dangerous, having less intent, and being less psychologically deviant. Additionally, students' punitive attitudes towards pedophiles diminished significantly. Also, a thematic analysis revealed that students were highly interested in the topic of pedophilia and greatly appreciative of Gabriel sharing his story. This study was the first to provide direct contact to a pedophile within an anti-stigma intervention.

### Introduction:

"Pedophilia" is a general term used to portray a paraphilia for which people have an extraordinary and industrious sexual enthusiasm for kids. In this proposal, the expression "individuals with pedophilia" (PWP) will be utilized as a general and de-defaming term when alluding to pedophiles. A "pedophile" alludes to individual with pedophilia, whether or not they have submitted kid sexual maltreatment or meet the full standards for pedophilic clutter. "Pedophilic issue" is a conventional analysis determined in the Diagnostic and Statistical Manual, fifth version (DSM-5)

(American Psychiatric Association, 2013) and is delegated a paraphilic clutter.

The conclusion must be additionally determined whether the individual is only pulled in to kids (Exclusive sort) or on the off chance that he/she is explicitly pulled in to other people (Non-restrictive sort), if sexual fascination applies to guys, females or both, also, if the desires are constrained to interbreeding (American Psychiatric Association, 2013).

### Methods:

The reasons for pedophilic clutter are easily proven wrong, and proposed factors incorporate an association of demeanor, hereditary qualities, natural and psychosocial factors (American Mental Association, 2013). People with pedophilia for the most part have been found to share a few shared characteristics, for example, encountering youth passionate, physical and sexual misuse themselves, just as family brokenness and social issues. These components can be considered as hazard factors for sexual enthusiasm for youngsters (Grattagliano et al., 2015; Lee, Jackson, Pattison,

and Ward, 2002). Basic comorbidities incorporate standoffish character turmoil, liquor and substance use issue, fanatical impulsive issue, burdensome, bipolar, and nervousness issue just as other paraphilia issue. Nonetheless, sex hormones are still created, and numerous people can live full sex lives after emasculation. Psychotherapy and social treatment incorporate individual and gathering treatment, psychological treatment, subjective social treatment and social medicines, for example, secret sharpening and trance. Different methodologies incorporate backslide avoidance, intended to build poise by showing people how to character triggers and adjusting methods for dealing with stress to shield from culpable or re-irritating (Stone et al., 2000). Pharmacological treatment incorporates hormones, SSRI and Anti-androgens expected to lessen sexual drive and thusly degenerate sexual conduct. Reactions shift between prescription (Stone et al., 2000). Not all medicines are reasonable and no particular type of treatment has not been reliably seen as more powerful than others (Stone et al., 2000).
