Functional medicine or Oligoterapia has its bases in the works of Gabriel Bertrand and Jacques Menétriér, initiated in the late 19th century and in the early decades of the 20th century. Gabriel Bertrand of the Pasteur Institute of Paris demonstrated the importance of minerals as biocatalysts of enzyme reactions. In the Scientific Congress of 1912, for some of these minerals have given the name "trace elements", as they are found in tiny quantities in living organisms, animals and plants.

Jacques Ménètrier uses any metallic substance, calculates how much is 1 (one) mol of the substance, through a simple calculation known in chemistry and quantifies mol of the substance and divides by 2. The result of the molarity is therefore ½ mol – half the molarity.
